Minor Amateur Athletic Waiver and Release of Liability

In consideration of being allowed to participate in any way in the **Blann's Kids Camp** (BKC) athletics/sports program, and related events and activities, the undersigned: **1. Agrees that prior to participating**, they know and understand the Rules of Competition, and that they (if under 18 years of age a Parent or Guardian) will inspect the facilities and equipment to be used, and if the participant and/or Parent or Guardian, believes anything is, or may be, unsafe, they will immediately advise their coach or supervisor and the BKC personnel of such condition(s) and refuse to participate unless and until such condition is remedied. **2.** Acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inaction's or negligence but the actions, inaction's or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time.
